Eligibility: Open to all USATT, CTTA or any other ITTF affiliate members and Non-members. Membership is not required.

Deadline: All paid entries received by August 28th will be guaranteed participation. Entries received after the deadline may be accepted on a space-available basis. Cancellation will only be refunded if notification is given before August 28th.

Check-in: Players should check-in as early as possible and should arrive **NO LATER** than 30 minutes prior to the starting time for their earliest event. (Note: The venue opens at 9:00am).

Rating: For event eligibility, we use the current USATT web site published ratings.

Format:

- **Double Round Robin:**
 - **First Round:** There are 6 players in each group (Max 36 People total)
 - **Second Round:** Based on the first round result – Winner's group, Second place group, Third place group and so on.
- All events are round robin for the first round. Subsequent rounds will be single elimination.
- **Top 2 players** from each group in the first round will advance to the next round
- All matches are 11 points best of 5 games, except for the final match of Open Singles, which will be best of 7 games.
- USATT rules and regulations will be enforced.
